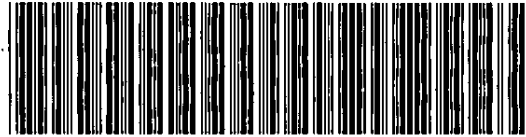

Dissolution of the corporation was approved and authorized on 9-23, 2014.


ARTICLE III. APPROVAL OF DISSOLUTION
