2. Article 1 of the Articles of Incorporation of LANG & ZIEGLER, P.A. is hereby amended in its entirety to read as follows:

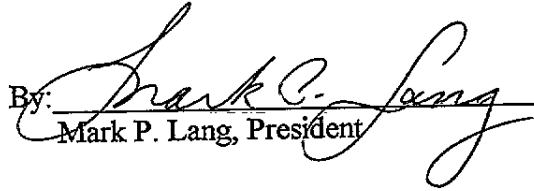
ARTICLE 1
