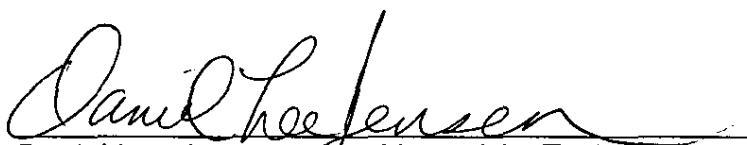
In the year 2000 we did not receive the Profit Corporation Annual Report. We moved our residence from 174 Peckham St. NE Palm Bay, FL 32907 to 3996 Snowy Egret Drive Melbourne, FL 32904. We followed proper procedure with the Post Office for forwarding of mail. All other State and Federal correspondence was forwarded to our new address, and we timely filed those returns. We do not know why we did not receive the Annual Report. We failed to recognize this mistake until just recently, when it was brought to our attention.

We are anxious to remedy this situation. In our attempt to reinstate our corporation, we found that our name ("JenTech Inc.") had been taken by another business. Therefore we have enclosed an Articles of Amendment form, as well as a Corporation Reinstatement form.

We are requesting the \$600.00 reinstatement fee be waived, as it was not due to intentional negligence, but rather to an oversight.

Enclosed is a check covering the missed annual report fees and corporate supplemental fees of \$150.00 each year, for years 2000 through 2003. This amount equals \$600.00. We have also included a \$35.00 fee for amending the Articles of Incorporation. The total check enclosed is \$635.00.
