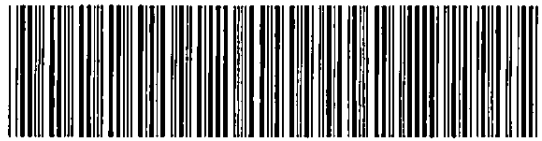

Pursuant to Section 607.1006 of the Florida Business Corporation Act and Section 621.13 of the Florida Professional Service Corporations and Limited Liability Companies Act, Q. Grady Minor and Associates, P.A., a Florida professional corporation (the "**Corporation**"), has adopted the following amendments to its Articles of Incorporation (the "**Articles**"):

1. The name of the Corporation is Q. Grady Minor and Associates, P.A.
2. The introductory paragraph of the Articles is deleted in its entirety and replaced with the following:

"The undersigned, being of full age, does hereby agree, for himself, his associates, and assigns, to become a corporation for profit under the provisions of Chapter 607 of the Florida Statutes, and does hereby accept all of the rights, privileges, and benefits, and obligations conferred and imposed by state law on corporations organized pursuant to the provisions thereof, and hereby makes, subscribes, certifies, acknowledges, and files these Article of Incorporation as follows:"

3. The text of Article I of the Articles is deleted in its entirety and replaced with the following:


"The name of the Corporation is Q. Grady Minor and Associates, Inc."
