**ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION

Pursuant to the provisions of Section 621.12 of the Florida Professional Service Corporation Act and Section 607.1006(1) of the Florida Business Corporation Act, due to the change of business of **BAY DERMATOLOGY ASSOCIATES, JERRY L. HEDRICK, M.D., P.A.** (the "Corporation") from solely the rendering of professional services (the practice of medicine) to include general business matters, the undersigned Corporation, in order to remove itself from Chapter 621 of the Florida Professional Service Corporation Act and to bring itself solely under the provisions of Section 607 of the Florida Business Corporation Act, hereby adopts the following Articles of Amendment to its Articles of Incorporation.

1. The name of the Corporation is **BAY DERMATOLOGY ASSOCIATES, JERRY L. HEDRICK, M.D., P.A.**

2. The following amendments to the Articles of Incorporation were adopted by the Shareholders of the Corporation on 19th day of July, 2013, and are to be effective the 26th day of July, 2013, in the manner prescribed by the Florida Business Corporation Act:

(a) Article I is hereby amended to read as follows: "The name of the Corporation shall be **BAY DERMATOLOGY, INC.**"

(b) Due to the change of business of this Corporation from solely

the rendering of professional services, i.e. the practice of medicine, to include general business matters, the undersigned Corporation hereby agrees to the removal of itself from Chapter 621 of the Florida Professional Service Corporation Act and agrees to be governed under the provisions of Section 607 of the Florida Business Corporation Act.

3. The number of votes cast for the amendment by the Shareholders was sufficient for approval.
