


Article I of the Articles of Incorporation is hereby amended, as of October 1, 2005, so that it now reads in its entirety as follows:

“ The name of the corporation is: 961 NW 7 St. Courtyard, Inc. a Florida corporation.”


Except as specifically amended hereby the Articles of Incorporation are reaffirmed in all respects.


