I.W.C. INTERNATIONAL, INC.**

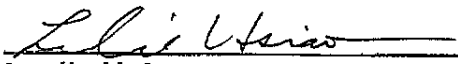

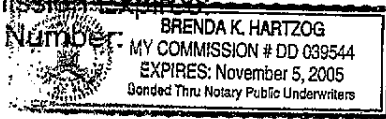
