To Whom It May Concern:


I am writing this letter as a result of my telephone conversation with a Ms. Ester Griggs, in the Division Of Corporations, on June 10, 2002.

In our conversation, I explained to her that I was going thru my corporate files and noticed that there was no Uniform Business Report in my files for year 2002. The more I thought about it, the more I didn't recall receiving the UBR in the mail. I checked in my checkbook to see if I had written a check for the filing fee. I found that there was no check written for that. So I went thru all of my files to see if I might have misfiled it by mistake and still could not find it. I have concluded that I did not receive the UBR in the mail, thus it was not sent in by May 1, 2002. Ms. Griggs said that she would mail another UBR Form to me and for me to fill it out and send it in with the \$150.00 Filing Fee along with a brief letter of explanation and it would be reviewed. I am complying with that suggestion.

I would also like to inform you that my corporation is a very small Sub-Chapter S Corporation, solely owned and operated by me. I have been incorporated in the State Of Florida since 1985 and have never been late in filing the UBR along with the filing fee before. The regular filing fee of \$150.00 is a financial burden as it is, the additional late fee of \$400.00 would be almost financially devastating. I would have to borrow some money to pay a lump sum of \$550.00.

In conclusion, I am sending in the UBR along with the filing fee of \$150.00 and this letter. I ask that the late fee be waived, excused or forgiven in light of the circumstances. Thank you very much in advance for your consideration and co-operation in this matter.
