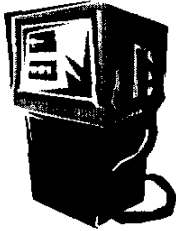


Please find the form and a copy of the letter that you sent me, regarding this issue. We did submit this previously and have our copy in the office.
