**ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION  
OF SWISS AMERICAN INDUSTRIAL SERVICE, INC.**

The undersigned corporation being SWISS AMERICAN INDUSTRIAL SERVICE, INC. a Florida corporation, the Articles of Incorporation of which became effective on November 4, 1985, resolves that the Articles of Incorporation be, and the same are hereby amended in the following particulars.

1. ARTICLE I "Name" is hereby amended to read as follows:
