ARTICLES OF AMENDMENT

TO

ARTICLES OF INCORPORATION

OF

PENINSULA BANK



Pursuant to Section 607.1006, Florida Statutes, the Articles of Incorporation of Peninsula Bank are hereby amended as follows:

<u>FIRST</u>: The first paragraph of Article III of the Articles of Incorporation is hereby amended by deleting the text thereof in its entirety and substituting the following in lieu thereof:

The total amount of capital stock authorized shall be 200,000,000 shares of common stock having a par value of \$1.00 per share and 1,000,000 shares of preferred stock..

SECOND: The foregoing amendment was adopted by the holders of in excess of a majority of the outstanding shares of common stock, being the sole voting group entitled to vote on the amendment, as of August 25, 2009 and the number of votes cast for the amendment was sufficient for approval by the holders of common stock.
