Dear Mr. Bodiford,

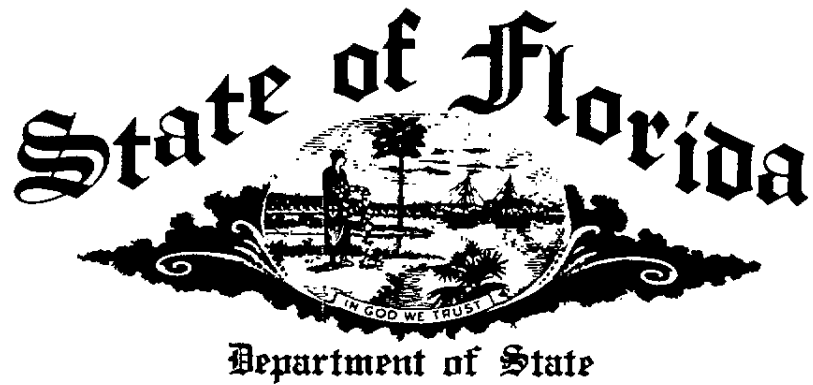
