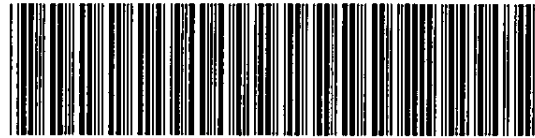

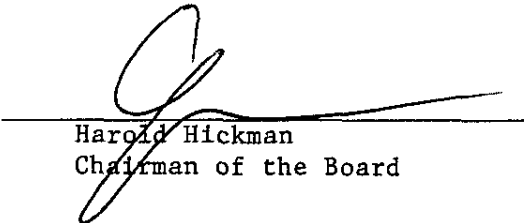
WHEREAS, the Company has ceased doing business; and,
