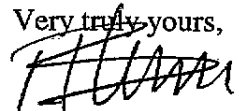

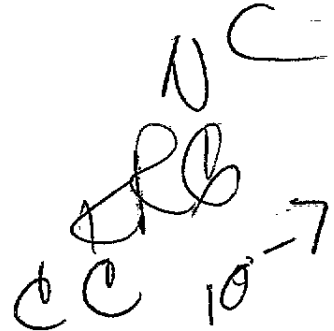

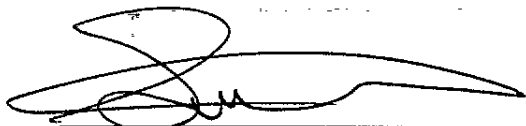

The name of this corporation is "Sidney M. Crawford, P.A."

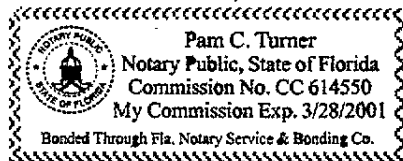
