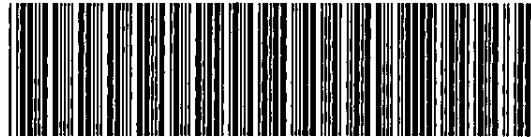

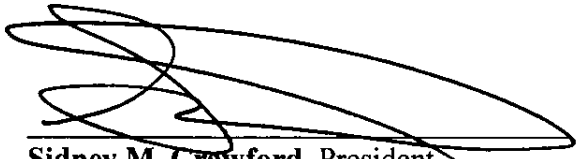

The foregoing Articles of Amendment have been executed by the President of the Corporation on this 26<sup>th</sup> day of March, 2007.

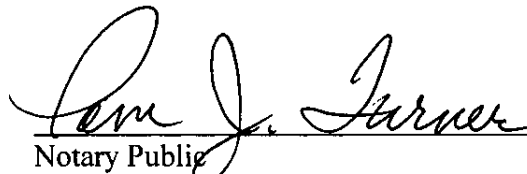
