Dear Ms. ASHTON:

I received on November 5 the above-referenced letter, which is dated October 5. Note that it took one month to reach me, even though the address is correct.

I completed and mailed the 2004 Annual Report for Montmorency Enterprises, Inc. on April 15. My check # 1393 in the amount of \$150.00 in payment for the filing of such Annual Report was also dated April 15, even though it did not clear my account until October 6. I do not know why my Annual Report and payment thereof were not processed in a timely manner. At this point in time, I rather think that April 15 being the last day for the filing of Income Tax Returns, my envelope might have been floating around the postal system overcome by a large quantity of mail on that date. The dating by you and receiving by me a month later of the above-referenced letter certainly reinforces doubts as to the reliability of timely mail delivery.

Finally, if you check my file, you will see that all Annual Reports since incorporation on February 5, 1992 were filed timely. There would have been no reason for it to be different this year.

Accordingly, I am sending you again my original 2004 Annual Report, and requesting that any Administrative Dissolution which may have been processed (I have been informed by "Tina" of your office that it had been so, even though I have received no written communication on this matter as yet) be rescinded, and my corporation be found in good standing.
