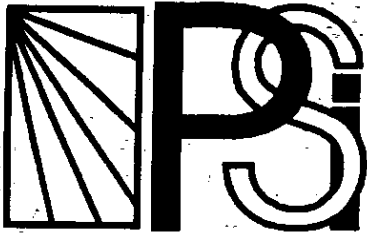


Dear Sirs:
