## AMENDED AND RESTATED ARTICLES OF INCORPORATION OF METHODIST FOUNDATION GIFT SHOPS, INC.

A. The name of the Corporation is Methodist Foundation Gift Shops, Inc.

B. Amendments to the Articles of Incorporation were adopted on August 30, 1999, by the Shareholders of the Corporation, to amend the Articles of Incorporation in their entirety to delete historical references, to change the registered agent and office of the Corporation, and to change the number and manner of election of the Board of Directors of the Corporation, so that after amendment, the Articles of Incorporation shall read as follows:
