ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF VANGUARD MANAGEMENT & INFORMATION SYSTEMS, INC.

Pursuant to the provisions of Sections 607.1003 and 607.1006 of the Florida Statutes, VANGUARD MANAGEMENT & INFORMATION SYSTEMS, INC. (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the Corporation is VANGUARD MANAGEMENT & INFORMATION SYSTEMS, INC.
- 2. The Original Articles of Incorporation of the Corporation were filed in the Office of the Florida Secretary of State on February 19, 1986 and assigned Charter No. J00022 and have been amended by Articles of Amendment filed on March 1, 1989.
