THIRD: The terms and conditions of the merger are as follows:

On the date the Articles of Merger are filed and accepted by the Secretary of State of the State of Florida, Norman Homes, Inc. ("Norman Homes"), Florida Cida, Inc. ("Florida Cida"), Rauch Corp., II ("Rauch Corp.) and Rauch Homes Inc. ("Rauch Homes") shall be merged with and into N. R. Homes, Inc. ("N. R. Homes"). The separate existence of Norman Homes, Florida Cida, Rauch Corp. and Rauch Homes shall thereupon cease and N. R. Homes shall continue its existence as the surviving corporation (the "Corporation") under Florida law under its present name. The parties hereto shall cause Articles of Merger to be executed and filed with the Secretary of State of the State of Florida and shall take all such other and further actions as may be required to make the merger effective. The merger shall become effective as of the date and time of the filing of the Articles of Merger (the "Effective Time").

The Certificate of Incorporation and Bylaws of N. R. Homes as in effect immediately prior to the Effective Time shall be the Certificate of Incorporation and Bylaws of the Surviving Corporation. The officers and directors of the Surviving Corporation immediately after the Effective Time shall be the respective persons who were the officers and directors of N. R. Homes immediately prior to the Effective Time.

FOURTH:

A. The manner and basis of converting the interests, shares, obligations or other securities of each merged party into the interests, shares, obligations or other securities of the survivor, in whole or in part, into cash or other property are as follows:

At the Effective Time, by virtue of the merger and without any further action on the part of N. R. Homes, Norman Homes, Florida Cida, Rauch Corp. or Rauch Homes or any holder of any shares

in any of such corporation, each share of N.R. Homes, Norman Homes, Florida Cida, Rauch Corp. or Rauch Homes issued and outstanding immediately prior to the Effective Time shall be converted into and exchanged for one share of the Surviving Corporation.
