We, the undersigned President and Secretary respectively of HARRISON, KIRKLAND, PRATT, CHULOCK & McGUIRE, P.A., a professional corporation organized under the laws of the State of Florida, hereby certify:

1. That the name of the corporation is HARRISON, KIRKLAND, PRATT, CHULOCK & McGUIRE, P.A.


2. The Articles of Incorporation of said corporation are amended to provide that the name of the corporation is hereby changed to HARRISON, KIRKLAND, PRATT & McGUIRE, P.A. and the previous name, HARRISON, KIRKLAND, PRATT, CHULOCK & McGUIRE, P.A., shall be deleted from the Articles of Incorporation in each and every place where it appears and the new name substituted in place thereof. Upon filing of this Amendment the name change shall be effective as of November 1, 2009.

3. In all other respects the Articles of Incorporation are ratified, reaffirmed and remain unchanged.
