Pursuant to Sections 607.1006 and 607.1007 of the Florida Business Corporation Act, the Articles of Incorporation of Beyen Corporation of America originally filed with the Secretary of State of the State of Florida on March 18, 1986, are hereby amended and restated in their entirety as follows:

Pursuant to Section 607.1006 and Section 607.1007 of the Florida Business Corporation Act, the following amendment and restatement to the Articles of Incorporation of the Corporation was duly authorized and adopted by unanimous written consent of the Board of Directors and the Shareholders of the Corporation in accordance with Sections 607.0704 and 607.0821 of the Florida Business Corporation Act on January 20, 2006.

**ARTICLE I
NAME**

The name of the corporation is IFR Monitoring USA, Inc. (the "Corporation").

**ARTICLE II
PRINCIPAL OFFICE AND MAILING ADDRESS**

The principal office and mailing address of the Corporation is 3333 West Commercial Blvd., Suite 202, Fort Lauderdale, Florida 33309.

**ARTICLE III
CAPITAL STOCK**

The aggregate number of shares of capital stock that the Corporation is authorized to issue is 1,000 shares of common stock, par value \$1.00 per share.

**ARTICLE IV
INDEMNIFICATION**

The Corporation shall indemnify any present or former officer or director, or person exercising any duties of an officer or director, and shall advance expenses on behalf of any such officer, director or other person, in each case, to the fullest extent now or hereafter permitted by law.
