FINAL JUDGMENT OF DISSOLUTION OF MARRIAGE WITH PROPERTY BUT NO DEPENDENT OR MINOR CHILD(REN)

This cause came before this Court for a trial on a Petition for Dissolution of Marriage. The Court, having reviewed the file and heard the testimony, makes these findings of fact and reaches these conclusions of law:

- 1. The Court has jurisdiction over the subject matter and the parties.
- 2. At least one party has been a resident of the State of Florida for more than 6 months immediately before filing the Petition for Dissolution of Marriage.
- 3. The parties have no minor children in common, and the wife is not pregnant.
- 4. The marriage between the parties is irretrievably broken. Therefore, the marriage between the parties is dissolved and the parties are restored to the status of being single.

SECTION I. MARITAL ASSETS AND LIABILITIES

- A. Date of Valuation of Property. The assets listed below are divided as indicated. The date of valuation of these assets, unless otherwise indicated, is March, 2005, which is the date of separation.
- B. Division of Assets.
- 1. Personal property. Each party shall keep, as his or her own, the personal property found to be in their possession which the Court has found to be non-marital, and the other party shall have no further rights or responsibilities regarding these assets.
- 2. Proceeds from the sale of real property. During the marriage, the parties built the marital residence located at 600 Southeast 59th Street, Ocala, Florida. The evidence established that the parties intended the home to be an investment to fund the wife's retirement. To that end, the wife
