12. *Chlorophyll a* and *Chlorophyll b* content of the leaves was determined by the method of Arnon and Whistler (1940). The leaves were extracted with 80% methanol and the extract was centrifuged at 10,000 g for 10 min. The supernatant was then transferred to a test tube and the absorbance was measured at 663 nm and 646 nm. The concentration of chlorophyll *a* and *b* was calculated using the following formulae:
