GROWER, KETCHAM, MORÉ, RUTHERFORD, NOECKER, BRONSON & EIDE, P.A., a corporation organized and existing under the laws of the State of Florida, under certificate number J06584, filed in the office of the Secretary of State on March 28, 1986, and amended on February 18, 1988, March 8, 1995, August 6, 1997, and April 5, 2000, hereby certifies as follows:

1. By written action dated the 4<sup>th</sup> day of January, 2002, the Board of Directors and Shareholders of the corporation adopted the following resolution:

**RESOLVED**, that the Certificate of Incorporation of GROWER, KETCHAM, MORÉ, RUTHERFORD, NOECKER, BRONSON & EIDE, P.A. be amended so as to change the name of the corporation to GROWER, KETCHAM, RUTHERFORD, NOECKER, BRONSON, EIDE & TELAN, P.A. and that Article I should be amended to read:
