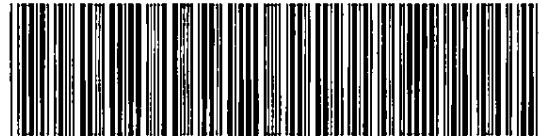


## RESOLUTION OF THE BOARD OF DIRECTORS

### Change of Firm Name






