Dear Sir or Madam:

Attached please find enclosed a copy of your *Certificate of Administrative Dissolution or Revocation* dated September 19, 2003 to the above corporation. Rodney E. Powell, M.D., P.A. is shocked and dismayed at this development, as are we, the accountants for the corporation.

After reviewing the current year's records and consulting with the taxpayer, it appears that the corporation did not receive the original 2003 Uniform Business Report to complete, nor did they receive any late notices; either of these would have reminded the corporation to satisfy its obligation. Research into Rodney Powell, M.D., P.A.'s filing history (through your related Internet site, www.sunbiz.org) shows an extensive record of timely filing, which would indicate that the corporation would have completed and submitted a UBR had it known it was still obligated to send one.

In light of said favorable history, and given Rodney E. Powell, M.D., P.A.'s statement of absence of any correspondence from the State before this dissolution, we respectfully request that the additional \$600.00 in charges be waived, and that the State accept the original \$150.00 filing fee due in March 2003. The taxpayer is submitting their reinstatement application along with this \$150.00 payment. If a reduction in charges is approved by your office, it would then be a simple matter to reinstate Rodney E. Powell, M.D., P.A. to current and active status as a corporate entity.
