## ORDER APPOINTING CUSTODIAN

THIS MATTER, having come before the court for hearing on th Petition of Broward Taff, Jr., was heard in Chambers in Wakulla County, Florida. Respondents, having no officers or directors, were present through attorney, Rick Benton, Esquire.

The Court having reviewed the Petition, heard testimony of the parties, and being otherwise advised of the premises finds:

- 1. The parties received notice of the hearing as evidenced by their presence;
- 2. This Court has jurisdiction of the parties and the subject matter of the action;
- 3. The shareholders of both A. B. Taff and Sons, Inc., "ABTS" and Shell Point Resort, Inc., "SPR" have failed to elect successors to the directors whose terms have expired by reason of resignation;
- 4. Both ABTS and SPR are suffering irreparable injury and further injury to the corporation is threatened by the inability to defend itself through management;
- 5. Both corporations are in danger of the wasting of their assets to the detriment of both their shareholders and their respective creditors;
- 6. It is in the best interests of the respective corporations that protection be afforded to the shareholders thereof and their respective creditors;

- 7. It is apparent that there are sufficient assets to provide adequate protection for the creditors, however, those assets are in grave danger of being deteriorated and wasted;
  - There is need of management for the benefit of the shareholders and creditors; 8.
- 9. Petitioner possesses the ability to serve as Receiver and/or Custodian of the properties;
- Petitioner has shown good cause, for this Court to grant the relief sought in the 10. petition, other than for dissolution or liquidation; and it is therefore,

## ORDERED and ADJUDGED that:

- Petitioner, Broward Taff, Jr., be and hereby is, appointed Custodian of the above Louproperties and is granted all power and authority requisite and needed to:
  - 1. Dispose of all or any part of the assets of the corporation wherever located, at a public or private sale, if authorized by the court;
  - 2. Sue and defend in his or her own name as receiver of the corporation in all courts of this state;
  - 3 Exercise all of the powers of the corporation, through or in place of its board of directors or officers, to the extent necessary to manage the affairs of the corporation in the best interests of its shareholders and creditors, including borrowing of funds for payment of taxes and direct expenses of the custodianship;
  - 4. File for protection under Title Eleven, U.S. Code. (Bankruptcy Code) in custodian's name as debtor in possession.
    - B) Petitioner is not required to post bond.
    - C) Petitioner shall account to the Court for any expenses paid and income received.
