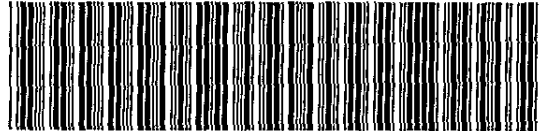

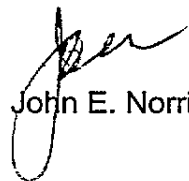

to be effective as of date of filing.

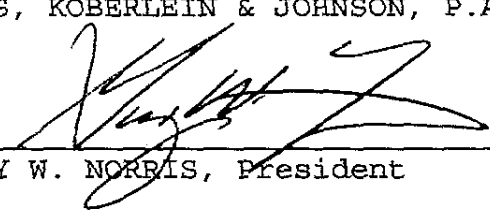
SECOND: The amendment was proposed by the Directors of the corporation on the 30th day of May, 2003.

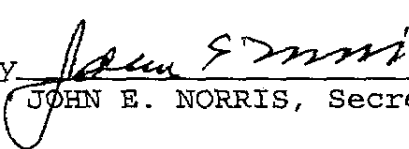

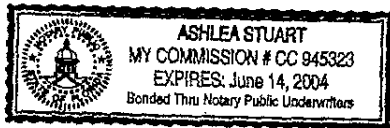
