AMENDMENT TO THE ARTICLES OF INCORPORATION OF PLANTATION ESTATES MOBILE HOMEOWNERS, INC.

- I. Article III of the Articles of Incorporation of Plantation Estates Mobile Homeowners, Inc. is amended to read as follows:
