ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF SOUTHEASTERN PROTECTION SERVICES OF FLORIDA, INC.

Pursuant to Section 607.1006 of the Florida Statutes, SOUTHEASTERN PROTECTION SERVICES OF FLORIDA, INC. (the "Corporation"), a corporation organized and existing under the laws of the State of Florida, under Document Number J14485, filed in the office of the Secretary of State on May 12, 1986, certifies as follows:

1. The director and sole shareholder of the Corporation considered amending the Articles of Incorporation so as to recapitalize the corporate structure by changing the authorized number of shares of stock to ONE HUNDRED THOUSAND (100,000), at a par value of \$0.01, of which Five Thousand (5,000) shares shall be voting common shares, and Ninety-Five Thousand (95,000) shall be non-voting common shares. After discussion, it was

RESOLVED, that the Articles of Incorporation of SOUTHEASTERN PROTECTION SERVICES OF FLORIDA, INC. be amended so as to increase the maximum number of shares of stock authorized to One Hundred Thousand (100,000), at a par value of One Cent (\$0.01), of which Five Thousand (5,000) shares shall be voting common shares, and Ninety-Five Thousand (95,000) shall be non-voting common shares, and that Articles IV shall be amended to read first entirety as follows:

"ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue One Hundred Thousand (100,000) shares of common stock having a par value of One Cent (\$0.01) per share. Five Thousand (5,000) of said shares shall be designated and known as voting common stock and Ninety-Five Thousand (95,000) of said shares shall be designated and known as nonvoting common stock. Except for voting rights, all shares of common stock shall be subject to the same rights and shall be equal in all other respects."

2. These Articles of Amendment were approved by the sole director of the Corporation and by the sole shareholder of the Corporation by joint written action dated October 35, 2016, which is sufficient for approval.
