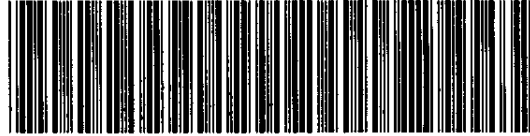

Upon any such occurrence, the trustee, receiver, executor, administrator, committee, guardian or conservator of the Director and/or Officer in question shall be deemed an assignee of such Director and/or Officer for the purpose of settling or managing the estate or property. As an assignee, the successor to the interest of such Director and/or Officer shall have only the rights of such member in the corporation income, gain, loss, deductions and distributions. The successor shall not be a substitute Director and/or Officer unless the Board of Directors consents to his/her admission as a substitute Director and/or Officer and neither such Director and/or Officer, nor the successor in interest shall have the right to demand immediate valuation and payment for such Director and/or Officer's interest.


