

FRED'S AUTO BODY, INC.


Pursuant to Florida Statute Section 607.187, the Articles of Incorporation are hereby amended as follows:

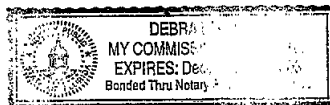
