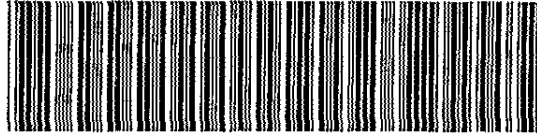



ARTICLES OF DISSOLUTION


Pursuant to Section 607.1403, Florida Statutes, this Florida corporation submits the following articles of dissolution:
