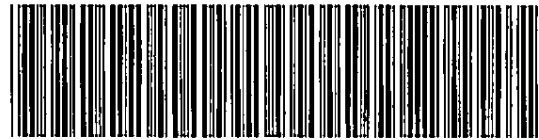

ARTICLES OF INCORPORATION OF

FIRST: The name of this Corporation is:

SPECTRA TRADING, INC.

SECOND: **RESTATED ARTICLES:** The text of the Restated Articles is as follows:

The mailing address and street address of the principal office of the Corporation is 6104 Boatrock Boulevard, Atlanta, GA 30336.

THIRD: **STOCK:** The aggregate number of shares of stock that this Corporation is authorized to issue at any one time shall be TWENTY THOUSAND (20,000) shares of common stock, with a par value of One Dollar (\$1.00) per share, divided into classes as follows:

10,000 shares of Class A Voting Common Stock; and

10,000 shares of Class B Nonvoting Common Stock.

Class A Voting Common Stock and Class B Nonvoting Common Stock have the same rights and privileges except that the Class B Nonvoting Common Stock does not have voting rights.
