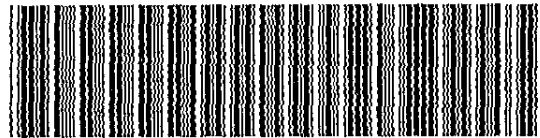

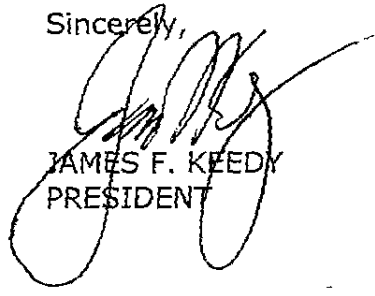

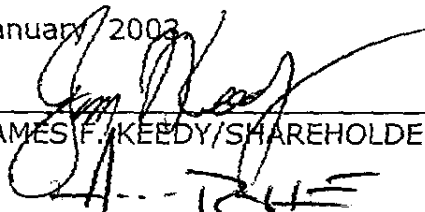
ARTICLE I. NAME

The name of the Corporation is: "KEEDY, ROHE & BURNETTE, P.A."

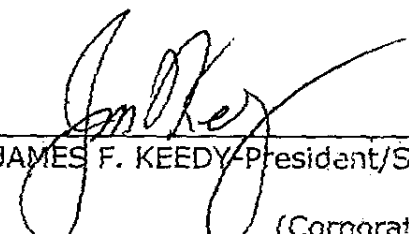
2. In all other respects, the Articles of Incorporation shall remain as they were prior to the Amendment being adopted.
