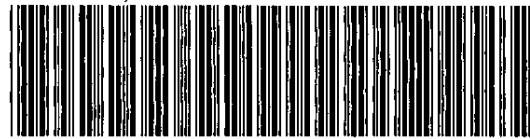



Pursuant to the provisions of Section 607.1006 of the Florida General Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The current name of the Corporation is PYRAMID II JANITORIAL SUPPLIES AND EQUIPMENT, INC.

2. The following Amendments to the Articles of Incorporation were adopted by all of the Directors and all of the stockholders of the Corporation eligible to vote. The number of votes cast for the amendments by the Directors and Shareholders was sufficient for approval of the amendments, in the manner prescribed by Section 607.1006 of the Florida General Corporation Act on June 29, 2012
