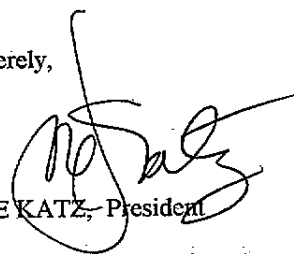

ARTICLES OF AMENDMENT

KNOW ALL MEN BY THESE PRESENTS: I, the undersigned, JOSE KATZ, President of SRP, INC., a Florida corporation, do hereby certify that the following Amendment to the Articles of Incorporation of SRP, INC., were approved by the Stockholders of said corporation on March 16, 1988.

AMENDMENT ARTICLE FOUR

4.01. Special meetings of the shareholders may be called at any time by the president.

4.02. A majority of the outstanding shares constitute a quorum for the transaction of business. Business may be continued after withdrawal of enough shareholders to leave less than a quorum.

4.03. Only persons in whose names shares appear on the share transfer books of the corporation on the date on which notice of the meeting is mailed shall be entitled to vote at each meeting, one vote for each share, unless some other day is fixed by the President of the corporation for the determination of record, but such date shall be not less than ten (10) nor more than sixty (60) days before the date of the meeting.

4.04. At all meetings, any shareholder may vote either in person or by proxy executed in writing by the shareholder or by his duly authorized attorney-in-fact. No proxy shall be valid after eleven (11) months from the date of its execution, unless otherwise provided in the proxy.

ARTICLE SIX

6.01. The business of the corporation shall be managed by a board of directors. These directors may take any action jointly and any such action shall be effective and binding upon the corporation.
