Enclosed is a check for \$150.00 for each of the above companies.

I request an exemption on the late fee. I have reached the age when my children were to look after these matters but they did not. My wife, of 40 years, and I have lived in Florida for the past 21 years and we closed P. A. Verona & Associates, Inc. nearly 10 years ago, around 1991. Since some vacant land remains titled to that company we have been advised to keep that corporation active. It is a sub chapter S so it has no tax implications if it were not to remain. When we travel our mail is forwarded to one of our children and in this case the smartest and brightest, our West Virginia medical doctor son, knowing that we closed the company assumed that the filing was not required. Of course, when he understood the facts he insisted that he pay the late fee but I cannot permit him to do that.

The La Famiglia Verona Corporation is very similar. The only asset it has is one broker account, which holds three securities. The value is less than \$22,000 and is owned by my children. If that company were dissolved we would simply transfer those securities to each child. This would cause some taxes to be paid by my children, which I would like to avoid. Maintaining the corporation for \$150 is viable but paying an additional \$400.00 would not make economic sense.

Again, I request that you accept my check for \$150.00 for each company and grant us amnesty. If not please return my check and send me the forms to dissolve these companies. Your consideration of this matter will be greatly appreciated.
