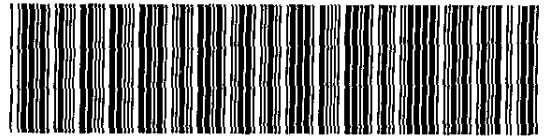

ARTICLE II - DISSOLUTION

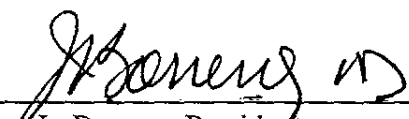
