AMENDED AND RESTATED ARTICLES OF INCORPORATION OF

MOUNT SINAI/MIAMI JEWISH HOME AND HOSPITAL HOME CARE CORPORATION

The undersigned officer hereby files these Amended and Restated Articles of Incorporation of Mount Sinai Home Care Corporation, (the "Corporation"), formerly known as Mount Sinai/Miami Jewish Home and Hospital Home Care Corporation, and hereby certifies as follows:

These Amended and Restated Articles of Incorporation were duly adopted by unanimous written consent of the shareholder and directors of the Corporation on February $\frac{\partial f^{d}}{\partial f}$, 1997, such unanimous written consent constituting a sufficient number of votes for approval. All amendments included herein have been adopted pursuant to Section 617.1007 of the Florida Business Corporation Act.

Articles I through VII are deleted in their entirety and replaced with the following Articles I through VIII.

ARTICLE I

The name of the corporation shall be MS HOME CARE CORPORATION (the "Corporation").

ARTICLE II

The general purposes for which the Corporation is organized are:

To provide home health and related services, including, but not limited to, physical, speech and occupational therapy, skilled nursing, medical social work, and home health aide services.

And in connection therewith and in furtherance thereof, to possess and exercise all the powers and privileges granted by the Florida Business Corporation Act or by any other law of Florida or by these Articles of Incorporation together with any powers incidental thereto.

ARTICLE III

The Corporation is authorized to issue 100 shares of common stock, par value \$.01 per share.

ARTICLE IV

The street address of the registered office of the Corporation is 4300 Alton Road, Miami Beach, Florida 33140 and the registered agent at that address is Alyson R. Serell, Esq., General Counsel.

ARTICLE V

The Corporation shall have three directors. The names and addresses of the directors of the Corporation, who shall hold office until their successors are elected and qualified or until their earlier resignation or removal from office are:

The number of directors may be increased or decreased from time to time pursuant to the bylaws of the Corporation, but shall not be less than three.

ARTICLE VI

ARTICLE VII

The Corporation expressly elects not to be governed by Section 607.0901 of the Florida Business Corporation Act, as amended from time to time, relating to affiliated transactions.

ARTICLE YIII

The Corporation expressly elects not to be governed by Section 607.0902 of the Florida Business Corporation Act, as amended from time to time, relating to control share acquisitions.
