# ARTICLES OF DISSOLUTION LEVIN EYE CENTER, P.A.

SECONDA PH 2: 01

Pursuant to the provisions of Sections 607.1402 and 607.1403 of the Florida Statutes, the undersigned Florida corporation hereby adopts the following Articles of Dissolution:

# Article I - Name of Corporation
