- FIRST:** The name of the corporation is Gulf Coast Health Technologies, Inc.
- SECOND:** Dissolution was authorized on January 25, 2001.
- THIRD:** Adoption of dissolution was approved by the shareholders. The number of votes cast for dissolution was sufficient for approval.
- FOURTH:** The assets of the Corporation shall be distributed as follows: 25% to Ft. Walton Beach Medical Center; 25% to Baptist Hospital, Inc.; 25% to Sacred Heart Hospital of Pensacola; and 25% to West Florida Regional Medical Center.
- FIFTH:** The Corporation is either (i) not indebted or (ii) has made arrangements to pay all of its debts.

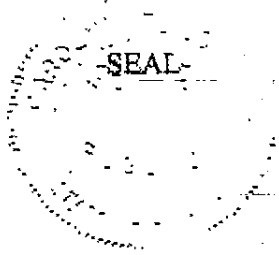
