At the time of the trial, the defendant was 21 years old and had a high school diploma. He was a member of the Black Panther Party and had been arrested several times for various offenses, including possession of a firearm and assault. The defendant was charged with first-degree murder and possession of a firearm. The prosecution presented evidence that the defendant was the shooter in the shooting of the victim. The defense argued that the defendant was not the shooter and that the victim was shot by an unknown person. The jury found the defendant guilty of first-degree murder and possession of a firearm. The defendant was sentenced to life in prison.
