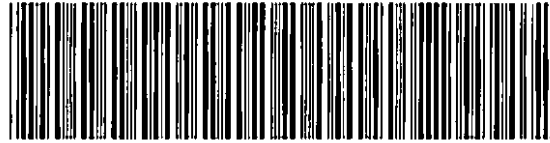

ARTICLES OF CONVERSION


