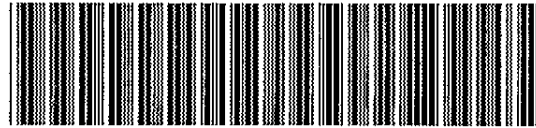

ARTICLES OF AMENDMENT
OF
PULMONARY AND CRITICAL CARE ASSOCIATES, P.A.

These Articles of Amendment are filed pursuant to Section 607.1006, Florida Statute, to reflect an amendment to the Articles of Incorporation of PULMONARY AND CRITICAL CARE ASSOCIATES, P.A., as amended by Articles of Amendment dated July 28, 1988, and June 20, 1990 (the "Corporation"), and in connection therewith, the undersigned officers, acting upon authority of the Board of Directors of PULMONARY AND CRITICAL CARE ASSOCIATES, P.A., hereby set forth as follows:

1. The name of this Corporation is: PULMONARY AND CRITICAL CARE ASSOCIATES, P.A.
2. The first paragraph of Article II of the Articles of Incorporation of PULMONARY AND CRITICAL CARE ASSOCIATES, P.A., as amended, is hereby amended to read as follows:

ARTICLE II

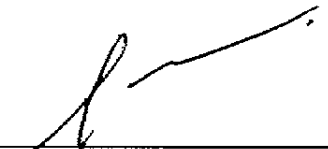
The general purpose for which this Corporation is organized shall be:

"To engage in every phase and aspect of the business of rendering professional medical services to the general public by or under the supervision of physicians duly qualified and licensed under Chapters 458 and 459, Florida Statutes, as amended from time to time, provided that such services shall be rendered only through employees and/or agents who are duly qualified and licensed, or otherwise legally authorized to render such services within the State of Florida."

3. Except as amended hereby, the Articles of Incorporation shall remain in full force and effect.

4. The Board of Directors and Shareholders of the Corporation adopted a resolution approving this Amendment to the Articles of Incorporation on November 14, 2002, to be effective November 14, 2002. The number of votes cast in favor of the Amendment by the Shareholders was sufficient for approval.

5. The undersigned, President of the Corporation, hereby certifies that these Articles of Amendment were duly adopted by the Corporation on November 14, 2002, to be effective November 14, 2002.
