ARTICLE I. - NAME

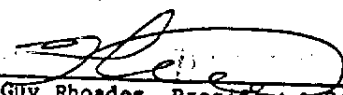

Incorporation shall remain unchanged.

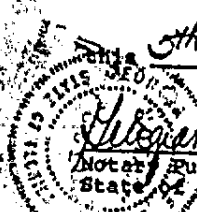
