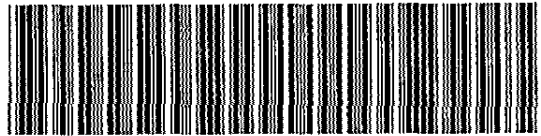

The name of the corporation shall be amended to be:

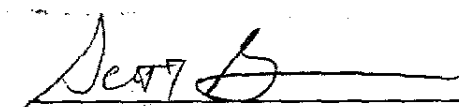
