"The name of this corporation is: ESCOBAR, GOMEZ, TOUGER & RAMIREZ, P.A."

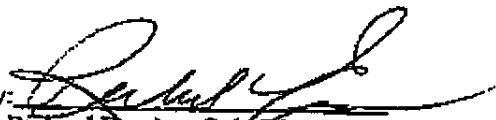
