1. Name. The name of the corporation is **ESCOBAR, RAMIREZ & ASSOCIATES, P.A.** (the "Corporation").

2. Articles of Incorporation. The date of filing of the Articles of Organization of the Corporation was November 12, 1986 (Document Number J41600).

3. Amendment. The Articles of Incorporation of the Corporation are hereby amended as follows:


Article 1 is deleted and a new Article 1 is inserted in lieu thereof, to read as follows:

ARTICLE 1 - NAME
